This is a joint meet and confer effort by all defendants in the above case. The Judge has denied your recent motions for reconsideration, stay or leave. There is a firm Court Order that your client pay our clients the attorneys fees cited by Judge White in his order granting the SLAPP and other motions to dismiss on or before this Wednesday, November 1. Your client will be in contempt of court if, by the close of business Wednesday, the ordered fees have not been paid.
