
27 This matter came before the court on Defendants Matthew Katzer and Kamind  
28 Associates, Inc.'s Administrative Motion to file under Seal dated October 14, 2008. The court  
29 has reviewed the parties' written submissions and finds as follows:  
30

1 Defendant Matthew Katzer's Declaration in Opposition to the Motion for Preliminary  
2 Injunction discussing harm that entry of a preliminary injunction would cause KAM contains  
3 confidential commercial information that should be protected from disclosure.

4  
5 Therefore, based upon the above findings and being fully advised in the premises, it is  
6 **ORDERED** that Defendants' Motion to Seal Defendant Matthew Katzer's Declaration in  
7 Opposition to the Motion for Preliminary Injunction discussing harm that entry of an injunction  
8 would cause KAM is **GRANTED**. It is further **ORDERED** that this Declaration shall not be  
9 filed on the ECF, but rather shall be marked "for attorney eyes only" and lodged with the Court  
10 and served pursuant to Civil Local Rule 79-5(b). It is further **ORDERED** that Plaintiff's counsel  
11 shall not disclose any information contained in the sealed portion of the declaration to anyone,  
12 including Plaintiff.


