
1 3. My clients have reasonably incurred attorneys' fees in connection with this special  
2 motion to strike in the amount of \$7,150. I have spent a total of 32.5 hours of legal time  
3 researching and preparing the anti-SLAPP special motion to strike papers. My billing rate is  
4 \$220 per hour. In addition, I anticipate spending at least an additional 20 hours of time at a  
5 billing rate of \$220 per hour reviewing Jacobsen's opposition, preparing a reply and attending  
6 the court hearing on this special motion to strike. This estimate does not include travel time from  
7 Oregon to San Francisco. The value of this anticipated time is \$4,400. Consequently, KAMIND  
8 Associates, Inc. and Matt Katzer ask that the court award them reasonable attorneys' fees for  
9 legal work associated with the anti-SLAPP motion to strike in the amount of \$11,550.

10 4. I am a 1997 graduate of the University of Texas School of Law. I have an LL.M. in  
11 environmental and natural resources law from the Northwestern School of Law at Lewis & Clark  
12 College. I have been licensed as an attorney in the State of Oregon since 2002. For the past  
13 three (3) years my legal practice has focused on environmental and commercial litigation in  
14 Oregon state and federal courts.

15 6. I am familiar with the legal fees charged by attorneys in the San Francisco area for  
16 handling matters similar to the instant patent infringement suit. My personal billing rate is below  
17 the rates charged by other lawyers with similar experience and qualifications.
